**RENEWALS:** All members receive a statement just prior to the end of each membership term. Those members who pre-paid their annual fee will have the option to lock in another year of membership at the prevailing rate by pre-paying for another one-year term OR to convert to another payment plan. Those members on a monthly payment plan may also renew for another one-year term and continue monthly payments at the prevailing rate OR may convert to another payment plan. Those members paying monthly who take no action within 30 days following the end of their membership term will automatically have their membership renewed on a month-to-month basis, with the monthly fee subject to change at anytime. Complete details of renewal options are described in the statement you receive. Additional membership term and payment offers may be available at the time of renewal.

**CANCELLATION POLICY:** Each membership carries a 30-day unconditional money-back guarantee. If you are not satisfied with your membership during the first 30 days, you may cancel without penalty and any membership fees paid to date will be refunded. Registration fees will not be refunded. Cancellations beyond 30-days incur a processing fee of \$50 and require either a valid military order or an exception granted by the Executive Director. Cancellation requests denied by the Executive Director may be appealed in writing to the Fort Ritchie Community Center Board of Directors. Contact the business office for a cancellation request form. 30-day notice is required to stop bank drafts of membership fee. Fort Ritchie Community Center is not responsible for overdraft fees.

### RELEASE and WAIVER of LIABILITY and INDEMNITY AGREEMENT

IN CONSIDERATION FOR PROGRAMS AND ACTIVITIES of the Fort Ritchie Community Center (FRCC) for any purpose, including, but not limited to observation or use of facilities or equipment, or participation in any off-site program affiliated with the FRCC, the signatory (or signatories) to this agreement, hereafter referred to as the APPLICANT, for himself or herself and any personal representatives, heirs, and next of kin, hereby acknowledges, agrees and represents that he or she has, or immediately upon entering or participating inspected and carefully considered such premises and facilities or the affiliated program. It is further warranted that such entry into the FRCC for observation or use of any facilities or equipment or participation in such affiliated program constitutes an acknowledgement that such premises and all facilities and equipment thereon and such affiliated program have been inspected and carefully considered and that the APPLICANT finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation.

IN FURTHER CONSIDERATION OF BEING PERMITTED TO ENTER THE FRCC FOR ANY PURPOSE INCLUDING, BUT NOT LIMITED TO OBSERVATION OR USE OF FACILITIES OR EQUIPMENT, OR PARTICIPATION IN ANY OFF-SITE PROGRAM AFFILIATED WITH THE FRCC, THE APPLICANT HEREBY AGREES TO THE FOLLOWING:

THE APPLICANT HEREBY RELEASES, WAIVES, DISCHARGES AND CONVENANTS NOT TO SUE the FRCC and all subsidiaries, affiliates, or parents thereof, and their respective directors, officers, employees, and agents (hereinafter referred to as "releasees") from all liability to the APPLICANT, his personal representatives, assigns, heirs, and next of kin for any loss or damages, and any claim or demands therefore on account of injury to the person or property or theft thereof or resulting in death of the APPLICANT, whether caused by the negligence of the releasee or otherwise while the APPLICANT is in, upon, or about the premises or any facilities or equipment therein or participating in any program affiliated with the FRCC.

THE APPLICANT HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE releasee and each of them from any loss, liability, damage or cost they may incur due to the presence of the APPLICANT in, upon or about the FRCC premises or in any way observing or using any facilities or equipment of the FRCC or participating in any program affiliated with the FRCC whether caused by the negligence of the releasees or otherwise.

THE APPLICANT HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence while in about or upon the premises of the FRCC and/or while using the premises or any facilities or equipment thereon or participating in any program affiliated with the FRCC.

THAT the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by the law of the State of Maryland and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding continue in full legal force and effect.
